

December 9, 2025

Supervisor Horr called the Regular meeting to order at 7:00pm. Roll call was taken, and found Councilperson Infantino, Colella, Luce and Bacon were present. Also present was Town Supervisor Gregory Horr, Highway Superintendent Scott Mitchell, and Code Enforcement Officer Danny Everett.

Pledge to the Flag followed, led by Councilperson Colella

Supervisor Horr opened the Public Hearing on Local Law #2 of 2025.

Comments: Councilperson Colella stated that the Livingston County Planning Board has reviewed and approved the changes.

Dan Folts LCN: Asked if the Zoning Law changes were made because of the crane issue. Councilperson Colella stated that the penalties that were added apply to any violation of the Zoning Law. He also stated that the Town is still working on the crane issue with LMC that will be beneficial for all parties. The FAA is stating that the Town is the owner of the airport and must enforce the regulations. The Town is working carefully to not affect business operations at LMC, but to find a solution satisfactory to all parties involved.

SEXTONS REPORT: Report for November 2025 was submitted. A motion by Councilman Luce, seconded by Infantino to accept the report as presented. All in favor. MOTION CARRIED.

Highway Superintendent Mitchell stated that the crew cleaned up the leaves until snow arrived.

Councilperson Colella asked where the board was with respect to a new building for the seasonal workers and the cemetery house. Superintendent stated they are still obtaining quotes for both rehabbing the house and a new maintenance building. A decision will be made next year when the board has all the information to decide.

HIGHWAY: Superintendent Mitchell stated that the state received our Local Highway Inventory Documents.

The shop roof that was recently re-done is leaking. Scott has reached out to JJM Roofing to look at it to see why.

Scott has also been working on prices for a new one-ton truck.

AIRPORT: Councilperson Bacon stated that fuel sales have dropped, which is typical for this time of year. There was no Airport Committee Meeting this month. They plan to meet on December 17<sup>th</sup>.

The board needs to make changes and suggestions to the advertisement for the Public Forum Meeting on January 5<sup>th</sup> for the financials of the airport. The plan is to have it ready for publication in the Genesee Valley Penny saver for 2 weeks at the end of December. The advertisement will be on our Town website, as well as our bulletin board. We plan on radio advertising the week before the event.

AUDIT REPORT: Review payroll, bank statements, Reconciliation. E-mails were sent to all board members Reconciliation Summary of Banking Accounts and Bank Statements (General, Highway, Airport, Water District and Trust & Agency) for the period ending November 30, 2025, for their review. The Town Clerk presented a hard copy of these materials for board review if they wish. Board members had no concerns with the information contained in the financial material.

**RESOLUTION NO. 12-01-2025  
A RESOLUTION APPOINTING A TOWN JUSTICE**

WHEREAS, the Town Board of the Town of North Dansville recognizes the need to fill the position of Town Justice due to a vacancy created by resignation; and

WHEREAS, pursuant to New York State Town Law and the Uniform Justice Court Act, the Town Board is authorized to appoint a qualified individual to serve as Town Justice until the next general election at which the office is required to be placed on the ballot; and

WHEREAS, the Town Board has reviewed the credentials of Scott Kenney and finds that this individual is duly qualified to serve in the capacity of Town Justice;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of North Dansville hereby appoints Scott Kenney to the office of Town Justice, effective January 1, 2026, to serve until the commencement of the term of the candidate elected at the next general election as prescribed by law; and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to file and transmit all necessary notifications of this appointment with the appropriate County and State agencies, including the New York State Office of Court Administration.

**RESOLUTION NO. 12-02-2025 A RESOLUTION IN SUPPORT OF CONGRESSMAN NICK LANGWORTHY'S ENERGY CHOICE ACT (H.R. 3699, S. 1945) AND IN OPPOSITION TO GOVERNMENT-MANDATED NATURAL GAS BANS**

Motion By Councilperson Colella, Second by Councilperson Bacon

WHEREAS, affordable and reliable energy is essential to the health, safety, and economic prosperity of New York families, businesses, and communities; and

WHEREAS, natural gas remains a dependable, cost-effective, and clean-burning energy source used by millions of New Yorkers to heat their homes, cook their food, and power their businesses; and

WHEREAS, in 2019, New York State enacted the **Climate Leadership and Community Protection Act (CLCPA)**, which mandates aggressive emissions reductions and serves as the foundation for sweeping energy restrictions, including efforts to phase out natural gas; and

WHEREAS, building on the CLCPA, Governor Kathy Hochul and the New York State Legislature in 2023 enacted provisions in the state budget banning natural gas and other fossil fuel hookups in most new residential and commercial buildings, effective 2026 for smaller buildings, and 2029 for larger buildings, thereby eliminating consumer choice and limiting access to affordable energy; and

WHEREAS, Governor Hochul has publicly supported these bans and related measures as part of her administration's climate and energy agenda, despite widespread concerns that such mandates will increase costs, strain grid reliability, and restrict energy diversity; and

WHEREAS, these top-down policies undermine affordability, threaten reliability during peak demand, and strip away the freedom of consumers and businesses to choose the energy sources that best meet their needs; and

WHEREAS, Congressman Nick Langworthy of New York and Senator Jim Justice of West Virginia introduced the **Energy Choice Act (H.R. 3699, S. 1945)**, federal legislation that ensures state and local governments cannot restrict consumer access to natural gas and other affordable energy sources, thereby protecting freedom of choice for New Yorkers and all Americans; and

WHEREAS, the Energy Choice Act would safeguard households, small businesses, hospitals, farmers, and manufacturers from harmful government overreach and preserve access to an "all-of-the-above" energy strategy that strengthens reliability and affordability;

NOW, THEREFORE, BE IT RESOLVED, that the Town of North Dansville strongly supports the Energy Choice Act as introduced by Congressman Langworthy (H.R. 3699) and Senator Justice (S. 1945) and stands firmly opposed to New York State's natural gas bans, the CLCPA-driven restrictions, and other state energy mandates that eliminate consumer choice; and

BE IT FURTHER RESOLVED, that the Town of North Dansville urges Congress to pass the Energy Choice Act to defend consumer choice, protect energy affordability, and preserve reliable access to natural gas for New Yorkers; and

BE IT FURTHER RESOLVED, that copies of this resolution be sent to Congressman Nick Langworthy, Senator Jim Justice, the New York Congressional delegation, Senators Chuck Schumer and Kirsten Gillibrand, Governor Kathy Hochul, and leadership of the New York State Legislature.

WHEREAS, a legal notice was placed in the Spectator informing the General Public of the Town of North Dansville of a Public Hearing scheduled on December 9, 2025, at 07:00pm with certified letters sent to all adjacent Towns, the FAA, and the NYSDOT informing them of the hearing, and

Resolved, with the passage of this resolution the Town Board of the Town of North Dansville does hereby adopt Local Law #2 of the Year 2025; and be it further

Resolved that the Town Clerk is instructed to submit this Local Law to the State of New York, Department of State for filing.
