There were 2 home steads on the property when they originally purchased the property. Their lawyer suggested having the two properties combined back into one parcel.

The floor was opened to the public for comments.

A member of the public stated that it was originally one parcel. A board member explained that the current zoning law states there cannot be 2 primary residents on the same tax parcel, which was before the zoning laws were in place.
